**Item No. 4 : Any other matter with the permission of chair.**

**i) Read letter received from Shri. Ravindra Dahad, Hon'ble Member, Fees Regulating Authority on 23/1/2018.**

It is pointed out that teaching staff – students – ratio has been changed. Earlier ratio of 1:15 has been lowered down to 1:20 – w.e.f: academic year 2018-19.

This Authority is in the midst of examining fee proposal for academic year 2018-19. Base of decision – is the income and expenditure statement of the academic year 2016-17. Admittedly, in the academic year 2018-19 the institution will have to follow ratio of 1:20 instead of 1:15. Therefore, their expenditure will be reduced.

One view is that : It is not desirable to enter into area of estimation of expenses of the college / institution, particularly for the reason that as a methodology / process of fees determination, we are not considering budgeted expenditure for subsequent years. Present method of fees determination based on the available financial statements is scientific and need not be discarded. Any estimation of expenses needs complete involvement of institution.

A glance at the fee structures which we have so far approved for the academic year 2018-19- shows that, huge amount of expenditure on account of un-approved staff is being disallowed (25% of the salary paid to un-approved staff). Invariably this is in case of all the institutions barring few. Thereby substantial cut in the expenditure under salary head is being ensured. Further 50% salary expenditure is disallowed if payment is in cash. Overall impact is in favour of stake-holders.



In order to address issue of decrease in the expenditure under head salary of teaching staff w.e.f. 2018-19 – detail discussion held. Dr. R.S. Mail has proposed some workable formula.

It is therefore, unanimously, resolved to proceed with examining fee proposals. In due course, Dr. R. S. Mali and Shri. Ravindra Dahad (as discussed today) agreed to come out with workable proposal / formula.

ii) **To consider the letter dated 18/5/2017 received from Smt. Vimladevi Ayurvedic Medical College & Hospital, Chandrapur regarding tuition fees to be collected from repeater students.**

Considered letter received from Smt. Vimladevi Ayurvedic Medical College & Hospital, Chandrapur.

Attention of the institution as invited to section 14 (6) which reads as under :


*"(6) The fees approved and communicated by the Fees Regulating Authority shall be applicable in respect of the candidate who is admitted to the unaided institution in that academic year and shall not be revised till the completion of the course of such student in the concerned institution."*

It is therefore, desirable that institution shall collect the same amount of fees which is approved by this Authority for a particular academic year. Under the Act, there is no provision of 5% increase in the subsequent year. Whatever, fee is declared for a particular academic year continues till the completion of course by such student in the concerned institution.
